Public Participation

- Stephanie Metts, Trenton's Suwannee Valley Quilt Festival, Inc.: Ms. Metts addressed the Board with a presentation of Trenton's Suwannee Valley Quilt Festival, Inc. She explained that what began as a display of several dozen quilts in Trenton's historic railroad depot, by students at the Suwannee Valley Quilt Shoppe, has grown to an annual event that is now Florida's largest outdoor quilt festival attracting approximately 5,000 visitors to the City of Trenton, in early March of each year. Trenton's Suwannee Valley Quilt Festival, Inc. was incorporated as a Florida Nonprofit Corporation, effective December 12, 2012.

Ms. Metts asked the Board to consider donating \$500 to Trenton's Suwannee Valley Quilt Festival, Inc., to help with the costs of the festival to be held on March 16, 2013. Discussion took place.
