



APPLICATION FOR COMMERCIAL USE PERMIT AT SANTA FE PARK

Pursuant to County Code section 64-4 (3), commercial entities must have written authorization prior to engaging in any regular commercial use of the County's parks or recreational facilities.

"Commercial use" means usage of any park or recreational facility or part thereof for any commercial purpose.

- (1) All commercial users of Santa Fe Park must apply for a permit from the county.
 - (a) The annual permit fee for commercial uses of Santa Fe Park is \$1,500 per year. Permits shall be valid from January 1- December 31 of the year in which the permit is purchased. Permits will NOT be prorated.
 - (b) Permits shall be limited to one permit per entity, business or individual at any one time as applicable. Permits cannot be issued for speculative use or purposes and shall only be issued to entities doing bona fide business within the park during the permitted year. All permitted entities must have placard furnished by county displayed on their vehicle(s), up to 3 vehicle placards per entity.
 - (c) There will be NO MORE than, (3) outside vendors, authorized for the Santa Fe Park each year, plus the County Concessionaire for a total of (4) vendors. Vendor applications are accepted on a 1st come 1st serve basis until the quota is filled each year. All existing outside permit vendors must be renewed annually no later than December 1st of each year in order to maintain their existing permit for the upcoming year.
 - (d) The county reserves the right to deny any application for a permit that does not meet the county's guidelines as well proof of insurance, liability, auto, workers compensation listing Gilchrist County as additional insured.
 - (e) A violation of any policy will result in immediate cancellation of permit with NO REFUND.
 - (f) Applicant affirms by their signature below that they are an independent contractor and are responsible and shall pay for and utilize their own equipment, pay for their own labor and employees benefits including but not limited to, all of its own employees benefits, payroll taxes and social security, as the vendor's sole responsibility. The vendor agrees that there is no partnership relationship created with Gilchrist County by this application, and the vendor is, and shall remain an independent contractor with full control over its business operations, subject to Gilchrist County rules as set forth herein.

Insurance and Indemnification:

Sole Proprietorship or Organization shall supply a “Certificate of Insurance” reflecting minimum liability coverage of \$1,000,000.00 bodily injury and \$100,000.00 property damage, automobile coverage and worker’s compensation coverage for all their employees. Gilchrist County BOCC shall be named as additional insured which shall be noted on the Certificate. The Certificate shall indicate that the Individual or Organization’s policy shall not be cancelled without 30-days prior written notice to Gilchrist County BOCC.

The Individual or Organization must provide the Certificate of Insurance to Gilchrist County BOCC before use of Santa Fe Park. The Sole Proprietor or Organization, including its contractor, agents and employees, shall also agree to indemnify and hold harmless Gilchrist County, its officers, agents, staff and employees from and against any and all liability claims, damages, expenses, fees, fines, penalties, suits, proceedings, actions, copyright violations, and other causes of action including reasonable payment of attorney fees of any kind and nature arising or growing out of and in any way connected with the Individual or Organization’s use of the facilities in accordance with this agreement.
