
#### Abstract

A RESOLUTION OF THE GILCHRIST COUNTY BOARD OF COUNTY COMMISSIONERS AMENDING THE OPIOID MITIGATION FUND BUDGET. THIS AMENDMENT INCREASES THE BUDGET FOR EXPENDITURES AND REVENUES FOR THE STATE OPIOID RESPONSE - SAMH PROGRAM. INCREASED BUDGET IS RECOGNIZED THROUGH THE USE OF UNANTICIAPATED GRANT FUNDING; AND ESTABLISHING AN EFFECTIVE DATE.


WHEREAS, Chapter 129, Florida Statutes, sets forth the requirements for the adoption of the annual county budget; and

WHEREAS, Gilchrist County did lawfully and appropriately adopt an annual budget for the Opioid Mitigation Fund (135) for Fiscal Year 2023-2024; and

WHEREAS, Chapter 129.06, Florida Statutes authorized amendments of the budget by resolution to lawfully expend revenues or fund balance or debt proceeds; and

WHEREAS, the Gilchrist Board of County Commissioners has approved the use of unanticipated grant revenue to fund these expenditures.

WHEREAS, the amount of Opioid Mitigation grant revenue is $\$ 109,018$.
NOW, THEREFORE, BE IT RESOLVED, by the Gilchrist County Board of County Commissioners that the Opioid Mitigation Fund (135) is hereby amended with an increased amount of \$109,018.
