**WHEREAS**, Chapter 129, Florida Statutes, sets forth the requirements for the adoption of the annual county budget; and

**WHEREAS**, Gilchrist County did lawfully and appropriately adopt an annual budget for the State Law Enforcement Trust Fund (120) for Fiscal Year 2024-2025; and

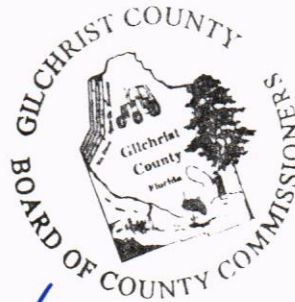
